Tournament Rules

1. All USBC rules and regulations will govern this tournament.
2. All entrants must be a current member of USBC. A 2016 -2017 USBC card must be presented at check-in. Should a bowler be unable to show their individual USBC sanction card, \$20.00 will be collected from the player for USBC membership dues.
3. ENTERING AVERAGES: All entrants will use their highest 2016-2017 USBC average of 21 or more games. Any bowler without an average on BOWL.COM, may use their highest 2017 summer league average, providing proof of average at check in. All others will have to bowl scratch. **All entrants, with average adjustments for tournaments must report prior to bowling, or risk being disqualified and forfeiting entry fee. If a bowler has been re-rated or refused a re-rate in the past 10 years, it must be reported at time of entry.**
 - A. The tournament committee reserves the right to adjust any bowler's average upward prior to their participation in the tournament. Failure to use the proper average the tournament Director will adjust the average and will base prize winnings on the submitted average if higher. USBC rule 319A-1, 319A-3 & 319C will apply to all participants. **Rule 319A-2 (Ten Pin Rule) will be waived. (Sport bowling averages will be adjusted according to Rule 203.)**
4. HANDICAP: 90% of 240 (based on a 3 game chart).
5. The tournament management has the right to add or delete a squad time. With no addition or deletion after 2:00 PM on July 16th.
6. Blind scores and pacers will not be permitted. Late bowlers will start scoring in the frame in progress upon their arrival, receiving zero for any missed frames. Substitutes must be present and checked in one (1) hour prior to scheduled shift to bowl.
7. All prize money will be returned 100% on a ratio of at least one (1) prize for each ten (10) entries in each event
8. Fees will not be refunded after entry forms and fees have been received and a definite squad assigned.
9. In the event of a tie for championship in any event, money will be equally divided and awarded.
10. Virtual Doubles Event: An optional Virtual Doubles event is offered for an extra fee of \$30.00 **PER DOUBLES**. Must bowl in the SINGLES event to be eligible. and your score for the singles event will be used for your Virtual Doubles event. (ONLY THREE GAMES WILL BE BOWLED, SINGLES SCORES ARE USED FOR THE OPTIONAL VIRTUAL DOUBLES EVENT.) **BOWL WITH AS MANY DOUBLES AS YOU WISH BUT THEY MUST BOWL IN SINGLES EVENT AND BOWLING ON SAME SQUAD.**
11. WALK IN & MULTIPLE PARTICIPATION WELCOME BASED ON LANE AVAILABILITY.
12. **DRESS CODE: All bowlers must wear a shirt with sleeves and collar.** Slacks, Shorts, Skirts & Jeans in neat clean appearance will be allowed. The following apparel is **NOT PERMITTED**: Tank tops, Halter-tops or any clothing with inappropriate writing, language or graphics.

Entries accepted up until 30 minutes prior to the last scheduled shift at 2:00 PM on July 24 subject to lane availability.

A. Doubles: a bowler may re-enter with the same or different partner, (but can only cash once with the same partner.)

Brackets will be available.
